1 Errata

- 1.1 The following points are made to correct minor errors in my evidence or clarify matters in my evidence in relation to the questions received from the Commissioner.

Paragraph 5.21

- 1.2 The third sentence in paragraph 5.21 should be amended to: “Having additional areas within the consented LTA area, but not necessarily built at the commencement of stage 2...”.

Paragraph 6.11

- 1.3 Paragraph 6.11 should be amended to replace “Table 5” with “Table 6”.

Paragraph 6.18

- 1.4 The last line in paragraph 6.18 should be amended to replace “(i.e. 178 vs 1 OverseerFM)” with “(i.e. 178 vs 142 Overseer FM)”.

Paragraph 6.27

- 1.5 The second line in paragraph 6.27 should be amended to refer to Condition 21 (instead of Condition 11).
- 1.6 The second line of the quote in italics in paragraph 6.27 should be amended to refer to Condition 20 (instead of Condition 10).
- 1.7 The third to last line of the quote in italics in paragraph 6.27 should be amended to refer to Condition 24 (instead of Condition 22).

Paragraph 6.28

- 1.8 The second to last line in paragraph 6.28 should be amended to replace “form” with “from”.

Paragraph 6.44

- 1.9 The third line in paragraph 6.44 should be amended to refer to Condition 18 (instead of Condition 11).

Paragraph 7.2

- 1.10 The third to last line in paragraph 7.2 should be amended to refer to Condition 21 (instead of Condition 11).
- 1.11 The second to last line in paragraph 7.2 should be amended to refer to Condition 7 (instead of Conditions 16 and 19).

Paragraph 7.4

- 1.12 The last sentence in paragraph 7.4 should be amended to refer to paragraphs 6.1 to 6.45 (instead of 6.1 to 6.436.45).

Paragraph 7.5(f)

- 1.13 The second to last sentence in paragraph 7.5(f) should be amended to refer to Conditions 16a, 16b and 18 (instead of Conditions 8, 18a, and 18b).

Paragraph 8.6

- 1.14 The sixth to last line in paragraph 8.6 should be amended to refer to 50 m bores (instead of 50 mm bores).

Paragraph 8.7

- 1.15 The third line in paragraph 8.7 should be amended to refer to Figure 3 (instead of Figure 1).

Paragraph 8.25

- 1.16 The first line in paragraph 8.25 should be amended to refer to Condition 3(b)(iii) (instead of Condition 3(b)(ii)).
