### Proposed Otago Policy Statement 2021 (Freshwater parts)

#### Minute 8

### Hearing Schedule and extension of time & cross examination requests

- - (i) 25 July 2023 by counsel for Royal Forest & Bird Protection Society of NZ Inc (RFB) regarding the timetable set in Minute 7 as to the intended process for responses on the NPS IB.
  - (ii) 26 July 2023 by counsel for Otago Regional Council seeking leave to cross examine 23 witnesses.

#### **RFB Memorandum**

- 2. This Memorandum described other hearing commitments which their counsel were heavily involved in which clashed with the dates set by the Hearing Panel for responses to the NPS IB in Minute 7. It concluded by seeking leave to address the NPS IB point as part of its legal submissions at the hearing.
- 3. The Panel has only received one such request and acknowledges the particular difficulties faced by RFB counsel. As only one such request has been made we do not consider that will unduly affect ORC counsel in being able to respond at its delayed closing presentation. Leave is accordingly granted to the request made.

#### ORC cross examination request

- 4. ORC counsel have sought leave to cross-examine 23 expert planning witnesses. The indicative hearing time provided is a total of 8 hours. The topics proposed are described by reference to particular provisions in the PORPS.
- 5. Clause 48 (1) of Part 4 of Schedule 1 of the RMA provides:

## 48 Procedures of freshwater hearings panel

- (1) Every freshwater hearings panel must—
  - (a) regulate its own proceedings in a manner that is appropriate and fair in the circumstances; and
  - (b) keep a full record of proceedings.
- (2) At a hearing, a freshwater hearings panel may—
  - (a) permit a party to question another party or witness:
  - (b) prohibit cross-examination:
  - (c) permit cross-examination at the request of a party but only if the panel is satisfied that it is in the interests of justice:
  - (d) regulate the conduct of any cross-examination.

- 6. The grounds advanced to satisfy the Panel that it is in the interests of justice to permit the cross-examination are listed at paragraph 4 of the Memorandum.
- 7. The Panel has closely considered those grounds and considers that each of them can best be described as general grounds in support of a proposition that general cross-examination of expert planning witnesses should be permitted. They are possibly best summarised by quoting paragraph 4.2 asserting that "the interests of justice are served by by allowing cross-examination of the expert planning witnesses". None of the grounds advanced assert a particular issue of disputed fact which needs clarification or correction.
- 8. In making open the opportunity to seek leave to cross-examine, rather than merely prohibiting cross-examination as is envisaged by sub-clause 48 (2) (b), the Hearings Panel had stressed that differences of opinion between experts do not normally raise issues of justice as between parties.
- 9. In the setting of this PORPS, however, the opportunity was left open to seek leave to cross-examine because the Hearings Panel was unaware at that stage as to whether any submitter or the Council asserted some significant issue of disputed fact existed underlying the freshwater provisions which may have been for example as to matters such as available flow rates or allocation effects. No such issue has been raised.
- 10. It is inevitable that planning witnesses in a regional policy statement process will have differing views, and even potentially widely differing views. Such differences are well able to be addressed by the process the Hearings Panel has in place of requiring submitter evidence to be lodged well before the hearings which enables the s.42A witnesses and ORC counsel to respond to that evidence in their openings. That in turn allows opportunity for further submitter response in their presentations at the hearing. ORC will then have opportunity to finally respond in closing presentations through s.42A reporters and counsel.
- 11. Through the Hearings Administration ORC have sought a short delay in hearing their final closing to be able to address any such submitter responses.
- 12. We are satisfied that process allows full understanding by ORC counsel and s.42A witnesses and by the Hearing Panel of any position advanced on any provision of the PORPS. We do not consider cross-examination would assist any further indeed in our view all that would be likely to achieve is an extended debate between two opposing views. That debate can be explored as fully as is required by the hearing process just outlined. (In passing we also observe that we have real doubts that the time sought of 8 hours was realistic, given the large number of provisions involved for each witness. Up to 17 for some.)
- 13. The request by ORC for leave to cross-examine is accordingly not permitted, and instead ORC's request for a short extra period to respond in closings is granted.
