Having accommodation on the proposed wharf build, with ease of access, and a wet area bathroom leads me to my particular interest of inclusion of those with disabilities to have the same facilities enjoyed by able bodied people. As a physically disabled person, for the first time in my life, I recently had the pleasure of a trip on a family boat up the Taieri River. This is a beautiful area that I had never had the chance to appreciate. However, the getting on and off the boat was a horror for me as my sons had to man handle me on and off the rocking boat from the wharf. This became a very



scary experience especially when the tide started to change. Physically able people have little or
no concept of how unstable and out of control these manoeuvres make a person feel. When you
have a stability problem and you cannot swim, you are faced with a challenge which involves water
and a boat in ever changing conditions. You need to feel as secure as possible to take the
opportunity to enjoy some of the pleasures that many other people take for granted. The disability
crane that will be open to the public in my opinion is critical for the reasons given above. I believe
the pontoon that the applicant's have made available to all emergency services 24/7 is a massive
asset to the community given nothing like this is available.

## Notes to the submitter

If you are making a submission to the Environmental Protection Authority, you should use form 16B.

The closing date for serving submissions on the consent authority is the 20th working day after the date on which public or limited notification is given. If the application is subject to limited notification, the consent authority may adopt an earlier closing date for submissions once the consent authority receives responses from all affected persons.

You must serve a copy of your submission on the applicant as soon as is reasonably practicable after you have served your submission on the consent authority.

**Privacy:** Please note that submissions are public. Your name and submission will be included in papers that are available to the media and the public, including publication on the Council website. Your submission will only be used for the purpose of the notified resource consent process

If you are a trade competitor, your right to make a submission may be limited by the trade competition provisions in <u>Part 11A</u> of the Resource Management Act 1991.

If you make a request under <u>section 100A</u> of the Resource Management Act 1991, you must do so in writing no later than 5 working days after the close of submissions and you may be liable to meet or contribute to the costs of the hearings commissioner or commissioners.

You may not make a request under section 100A of the Resource Management Act 1991 in relation to an application for a coastal permit to carry out an activity that a regional coastal plan describes as a restricted coastal activity.
