

I have a right to have water, this application could seriously jeopardize this as an effected land owner downstream.

Who knows how much water flow there will be in the Royal burn in the future, this should be serious looked at before anything is granted.

The Historic Brodie cottage which is part of my property and has the brodie creek running through it has had small fish species in it for years, my children on many occasions would catch yabbies in that creek.

This creek has been serious effected over the last few years since upstream development has happened

This creek always had flow even in the dryer seasons, now there is significantly less flow even on some occasions running dry.

I fully object to this application as a resident of the Crown Terrace of 28 years, and part of the LOFTS water scheme which can take up to 25000 L per day downstream of the Applicant

Council gave me a consent to build this property 25 years ago. Part of my consent regarding water rights was giving to me on the grounds that I was part of the LOFTS scheme in which gives me up to 2500 l per day.

This is a major concern with the quantity and Quality of water if this application is approved.

The water intake for the LOFTS water scheme is downstream of the applicant.

The water scheme has already drastically changed over the last 5 years, in both quality and quantity.

The build up of slime and algae around the top of our tanks has only happened since the introduction of a golf course and commercially grown ready lawn operation on the same property upstream.

I,m no Green Keeper or turf Specialist, but you don't have to be a Rocket Scientist to know these sort of operations run on toxic chemicals.
